From 2005-2015, I published 29 journal articles on topics such as infant, fetal and perinatal mortality, preterm birth, cesarean section, and out-of-hospital births. Since 2005, I have authored 30 NCHS publications on topics such as international infant mortality rankings, fetal and infant mortality trends, out-of-hospital births, and understanding racial and ethnic disparities in infant mortality. Since 2005, I have given 12 contributed presentations at scientific meetings, and 33 invited

presentations for groups such as the Secretary's Advisory Committee on Infant Mortality (2), and various NIH panels (3).

Since 2005, I have briefed Congressional staffers 7 times on issues related to infant and fetal mortality. I am frequently called upon to review draft Congressional legislation on topics related to infant health.

I also have extensive experience in working with state partners. I am currently a member of the COIIN Data for Improvement and Innovation Committee. I was a member of the planning team for the State Infant Mortality Collaborative (SIMC), a CDC-led project to assist states with high or increasing infant mortality rates to lower them. In this context, I worked with state staff to analyze their state infant mortality data and to devise prevention efforts, and I gave two presentations at annual SIMC meetings. As outlined below, I have worked extensively with our state partners in planning and conducting the ECLS-B survey, and have given 3 invited presentations to state audiences since 2005.

During this period, I also did considerable technical and file work, as I participated in reviewing the annual linked birth/infant death data sets and fetal death data sets prior to their release to the public. With Elizabeth Gregory, initiated a catch-up program for fetal death data release that resulted in 6 years of fetal death data being released to the public within a 9-month period in 2013-2014, and earned us a NCHS Director's Award in 2014.
